Terms & Conditions:

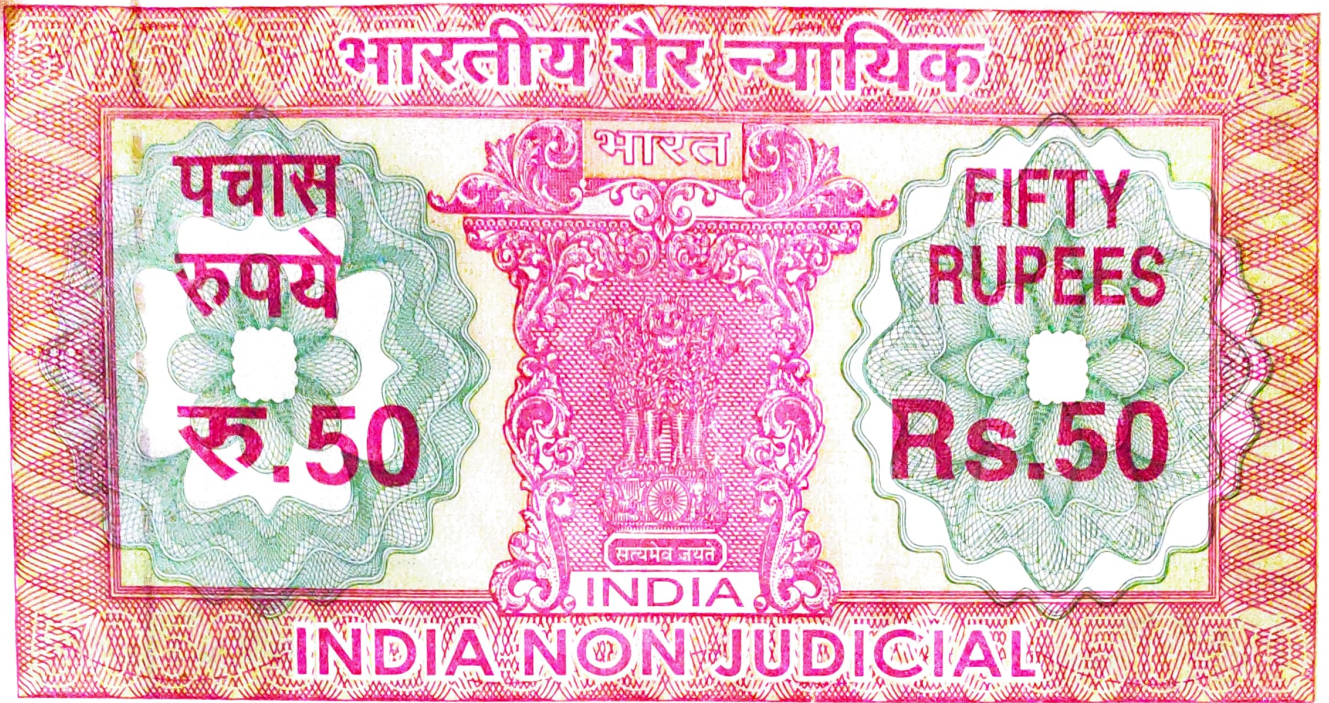
1. Program will be conducted at the Second party's premises.


